

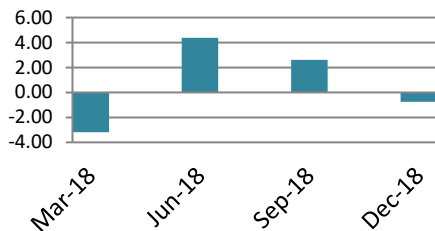

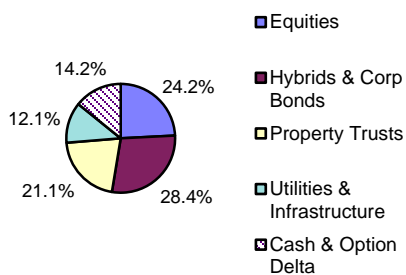
Investment Objective

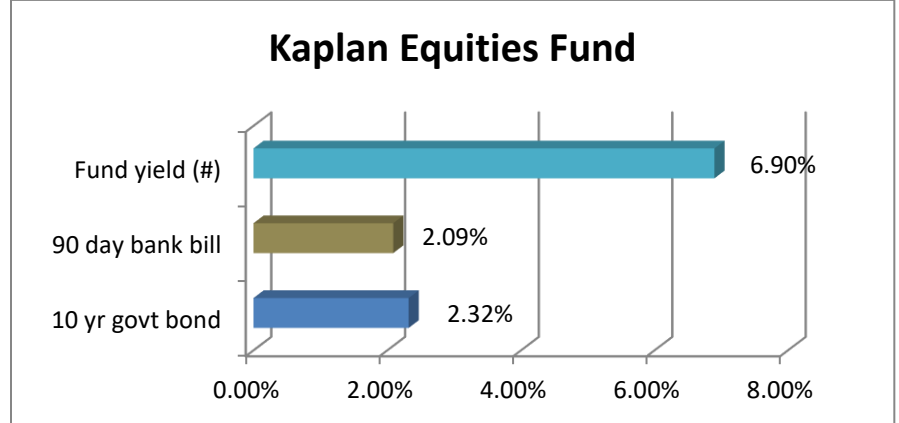

Fund Running Yield (inclusive of franking credits)



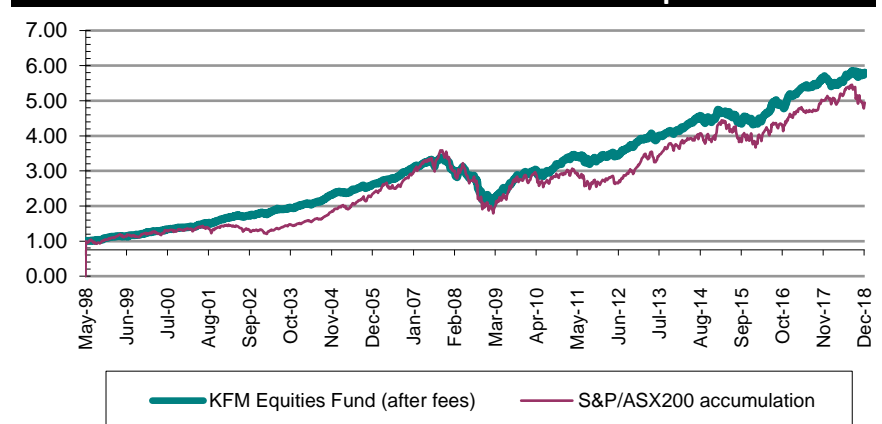
