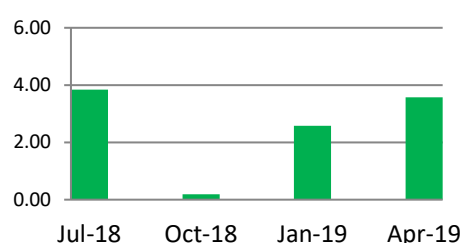

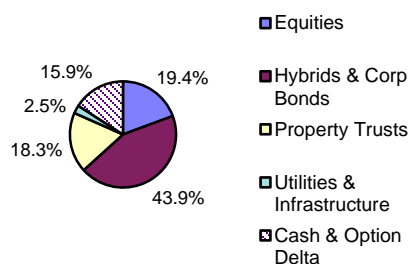
### Investment Objective

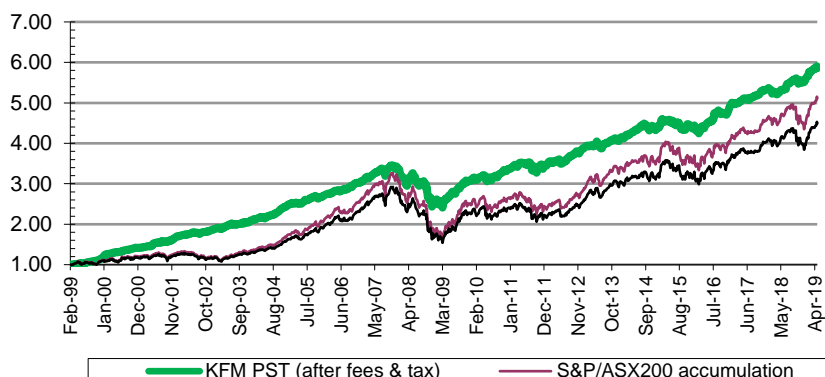
