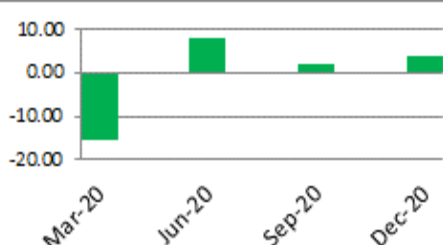

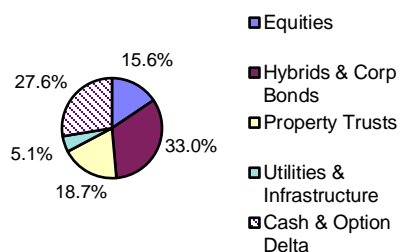
Investment Objective

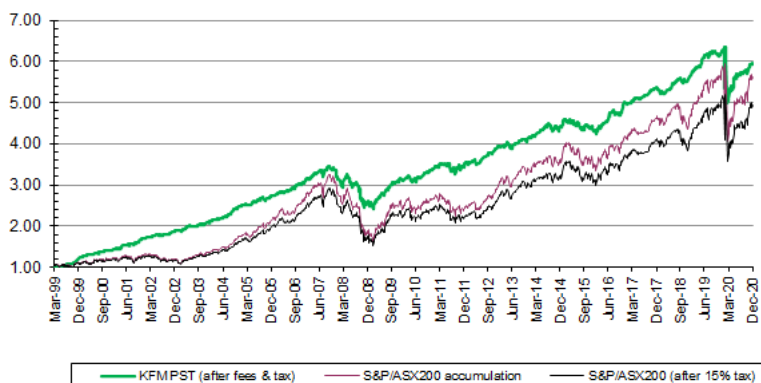
