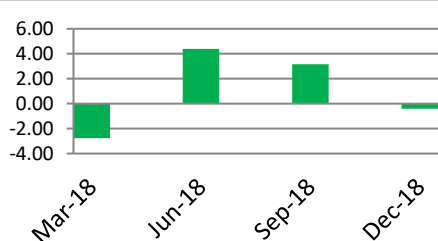

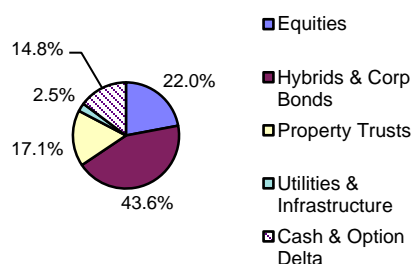
Investment Objective

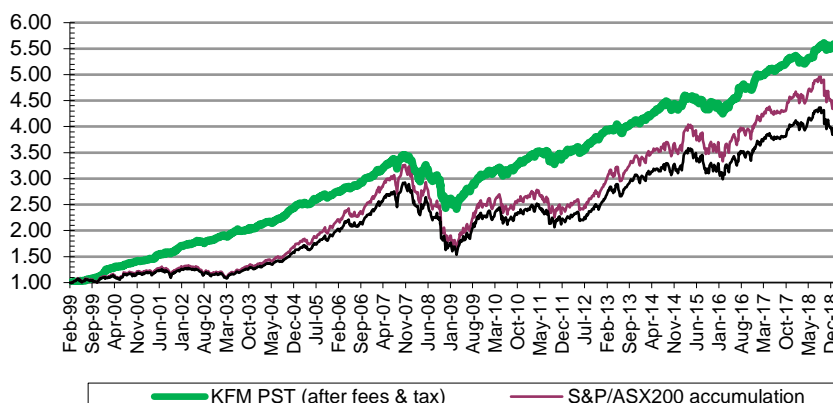
