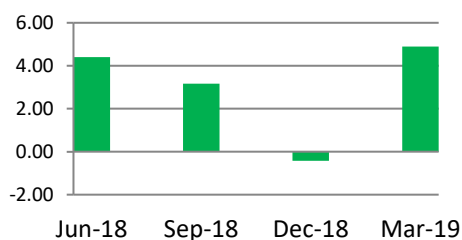

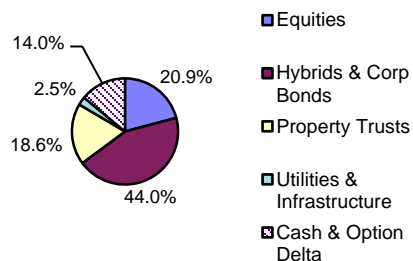
Investment Objective

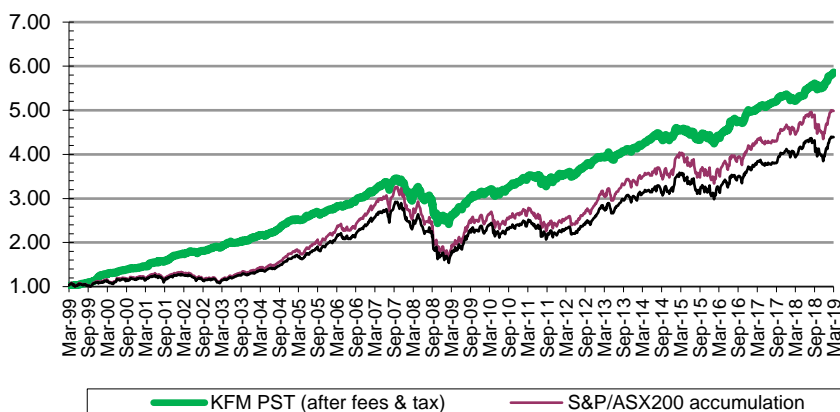
