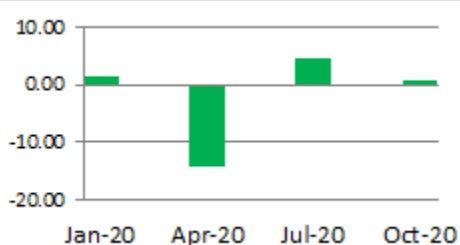

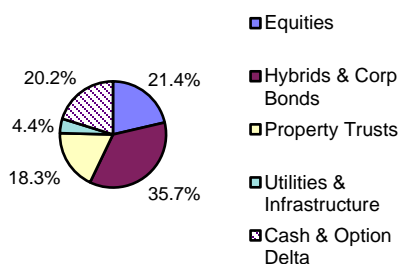
Investment Objective

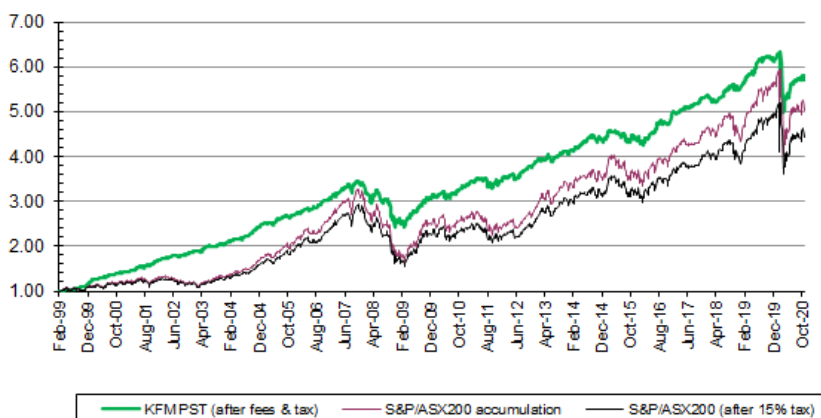
